**WALK IN INTERVIEW FOR THE POST OF JUNIOR RESIDENT**

Applications are invited in the prescribed format from eligible candidates for making a panel for appointment against existing and future vacant posts for Junior Resident on **ad-hoc basis** extendable upto a maximum period of 89 days with annual extension provided that the service rendered/work and conduct has been found to be satisfactory & requirement of the hospital till suitable/regular JRs appointed. Selection will be purely on merit based on interview

Willing candidates are requested to report on date of interview with their Bio-Data, two passport size photographs alongwith attested copies of certificates in the office of the Medical Superintendent, Attar Sain Jain Eye & General Hospital, Govt. of NCT of Delhi, Lawrence Road, Delhi-110035.

The candidates will be allowed to appear only on production of original certificates/ No letter will be issued separately. No TA/DA will be paid for appearing in the interview.

**Eligibility:**

1. MBBS Degree recognized by National registered body.
2. Registered with Delhi Medical Council.
3. Should have completed internship within 02 years of date of interview and preference will be given to fresh candidates.
4. Non-PG candidates will be preferred over PG candidates

**Age Limit:** - 30 years for General (5 years relaxable for SC/ST, 3 years relaxable for OBC and 5 years extra relaxable for Persons with Disabilities candidates)

**Tenure:** - The tenure of junior resident is for a period of one year only including any service rendered as junior resident earlier on ad-hoc basis in any recognized institution. The tenure of Junior Resident is for a period of 89 days including extended further upto a maximum period of 1 year subjected to satisfactory work and conduct report from concerned incharge.

**Emoluments:** - Shall be in accordance with 7th CPC Pay Matrix Level 10 (Pay Rs. 56100/- plus allowance) as admissible under the rules.

**Date of Interview:** 05.03.2024 (Tuesday)

**Time of Interview:** 10:00 AM onwards on above mentioned date.

**NOTE:-**

1. Number of the posts is provisional and subject to change according to vacancies without any notice.
2. Seats will be reserved for differently abled candidates as per prevailing govt. rules.




3. The decision of the Selection Board /Medical Superintendent ASJ Hospital regarding selection will be final and binding and no representation will be entertained in this regard.
4. Appointment will be initially for a period of 89 days extendable up to maximum of one year on the basis of satisfactory Work & Conduct report from the concerned HOD and written request from the Doctor concerned.
5. The contract of appointment can be terminated by either party by giving a notice of seven days in case of Adhoc without assigning any reason.
6. If any declaration /information furnished by the candidates are found false or any material/fact suppressed willfully, the candidature/appointment will be cancelled/terminated forthwith, due Administrative action/ legal action will be taken. Delhi Medical council will also be intimated for appropriate action.
7. No TA / DA shall be paid for participating in the selection process

**Terms and Conditions: -**

1. Candidates must have a valid DMC Registration Certificate.
2. SC/ST certificates issued from Judicial/Revenue Authorities and OBC Certificates issued from the Govt. of Delhi shall only be accepted. **Further reservation to handicapped candidates shall be given as per Rules.**
3. In case of Non-availability of candidates under SC/ST/OBC Category, vacancy may be filled up from the General category and Vice Versa on Ad-Hoc Basis.
4. List of eligible candidates shall be displayed on the website of H&FW Department. No separate call letters shall be sent.
5. Candidates are required to bring all original certificates and testimonials along with two recent passport size photographs on the date of interview.
6. Appointment shall be subjected to medical fitness and verification of certificates.
7. **Submission of application:** - Interested candidates may report on **05/03/2024 (Tuesday)** for registration from **9:30 AM till 11:00 AM** in the Establishment Branch with filled **application form** along with photocopies of qualifying certificates, date of birth proof (Class X Certificate), DMC Registration, Aadhar Card/Photo ID Card, Caste Certificate (if any). Only those candidates whose registration is completed by **11:00 AM** shall be eligible for appearing before the interview board. All original documents must be produced for verification.
8. The Post Graduate Doctors who are interested to serve as Junior Residents should mention in the application form & will be allowed to join as Junior Residents if fresh graduates are not available.
9. The decision of the selection board regarding selection will be final and binding and no representation will be entertained in this regard.
10. The services of JR will be governed by Residency Scheme of Govt. of India/Govt. of NCT of Delhi/Civil Services.
11. All candidates are exempted from payment of Fee.
